University of Rochester

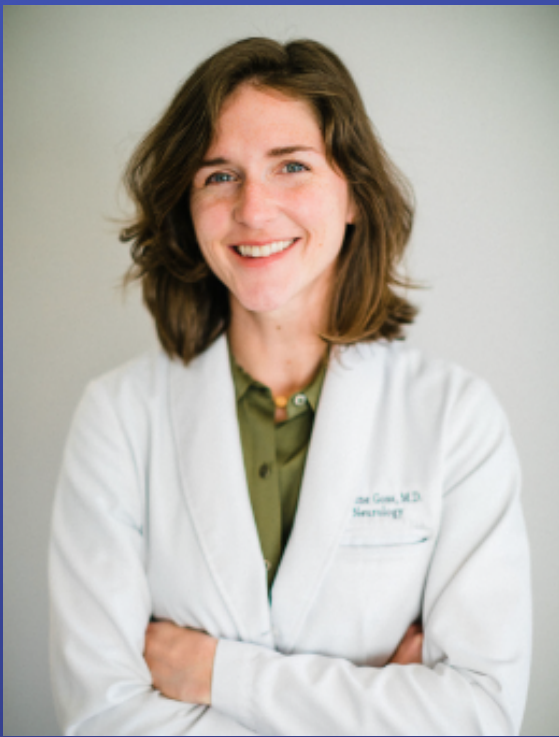
